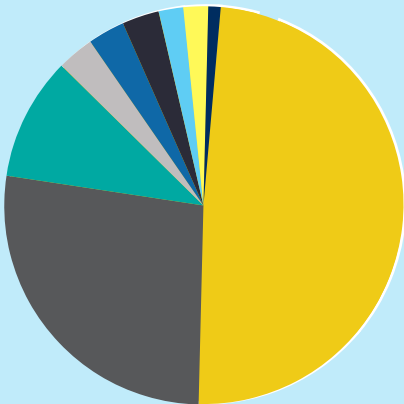

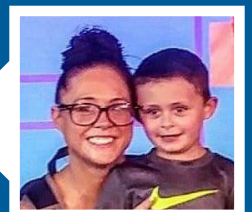

Last year, Florida's unemployment rate spiked from **3.3%** to **14.2%** in 3 months. (DEO)

21% of our clients' legal problems were caused or worsened by COVID-19 in 2020.

11,227 evictions were filed in Hillsborough and Pinellas Counties from March 2020 to March 2021.

We helped with **3,167** housing issues last year to prevent housing instability throughout the pandemic.

WHAT WE'VE BEEN DOING

- Our services play a key role in preventing people from falling further into poverty by helping with issues such as homelessness, domestic violence, fraudsters, physical and mental health benefits, and more.
- We launched pro bono projects like FACE (Florida Attorneys Counseling on Evictions) and our Frontline Heroes Project, and expanded our Disaster Relief program to fight the wave of evictions and other legal matters that arose during the pandemic.
- We created an online COVID-19 Resource Guide; worked with city officials, partners and news outlets; and created a #LegalAnswersLive Facebook series to educate the community about the changing resources and rules.
