Is Your Rent Past-Due Because of COVID-19?

RAPID RESPONSE RECOVERY PROGRAM (R3)

Helping Hillsborough County residents pay for up to \$7,500 in past-due rent and up to \$750 in past-due electric bills.

- **Tuesday, March 23 at 10 AM:** Applications open for eligible households at or below 50% AMI or with zero income 90 days prior to application submission
- **Monday, April 12 at 8 AM:** Applications open for eligible households at or below 80% AMI

OTHER RENTAL ASSISTANCE PROGRAMS

R.E.A.C.H.

*Residents of Unincorporated Hillsborough County, FL including Plant City and Temple Terrace may be eligible for mortgage and rental assistance. The program runs from **February 5, 2021 through December 30, 2021** or until no more funding. Funding is through the Federal CARES Act.*

MINIMAL REQUIREMENTS (see application for additional documentation needed)

- All household members 18 years or older must sign and date the application and duplication of benefits form.
- All household members 18 years or older must provide a completed and signed Social Security form.
- Total household income cannot exceed amounts in the table below.

ALL DOCUMENTS MUST BE SENT WITHIN 3 BUSINESS DAYS OR YOUR CASE WILL BE CLOSED OUT

DOCUMENTS TYPICALLY NEEDED TO APPLY FOR PROGRAMS

- Current lease
- Landlord W-9
- Landlord verification
- Government issued ID
- Letter from employer, unemployment office or doctor stating job loss, reduced hours and/or quarantined **due to COVID-19**
- Provide past due payment notices from the landlord or property management company
- Provide sources of current annual income for all household members for the last 30 days
- Social Security benefit statements
- Pension statements
- Valid social security identification and valid state issued photo identification for each household member

Applications will be accepted through December 31, 2021.

Household income must be at or below 80% of Area Median Income.
